



# UPDATES & PRACTICE ISSUES

## NEW POLICY STATEMENT

The Policy Statement has been updated to reflect recent changes in personnel. It is important to ensure that you have the newest version on display. It is also available in Irish and Polish. All other posters i.e. Altar Servers, Children's Liturgy, Children's Choir along with information leaflets have been updated accordingly. Copies are available from the Safeguarding Children Office.

## POLICY & PROCEDURES

The 2014 Policy & Procedures and Booklet has now been replaced with a direct link the National Board's website. This gives you access to the most updated procedures and guidance. Each Standard is displayed separately. By scrolling over the Standard, you will be able to access all guidance and relevant forms associated with each standard.

## GARDA VETTING

The National Vetting Bureau (Children and Vulnerable Persons) Acts 2012 to 2016 provide a statutory basis for mandatory vetting of persons whose work brings them into contact with children and/or vulnerable adults. Within parishes, all clergy, sacristans, children's liturgy leader, children's choir leaders, altar server leaders and all those who work with children must undergo garda vetting. The re-vetting period has changed from 5 to 3 years in line with the guidance of the National Board for Safeguarding Children in the Catholic Church.

Re-vetting is every 3 years.

# STANDARD 1

## Creating & Maintaining Safe Environments - Practice Issues

### Visiting Clerics or Visiting Persons in Any Form of Consecrated Life Ministering at Shrines, National Shrines and International Shrines.

*Definitions:* A Shrine is a Catholic church or other sacred place which with the approval of the local ordinary is by reason of special devotion frequented by the faithful as pilgrims (Canon 1230). To be considered a National Shrine the approval of the National Irish Episcopal Conference is necessary. For it to be described as International, the approval of the Holy See is necessary (Canon 1231).

### For Visiting Clerics or those in any form of consecrated life, ministering in Shrines and National Shrines in Ireland

prior to the visit, where there is an intention to engage in public ministry, all visiting clerics and those in any form of consecrated life must follow Guidance 1.1C.

In particular:

- If the visiting cleric is ministering at a one-off event which is not considered a regulated activity, he must provide his celebret for inspection by the parish priest or duly delegated person and this should be noted beside the visitor's signature in the register.
- If the ministry is for a short-term basis, the visiting cleric must follow the requirements set out in Guidance 1.1C. If the ministry is being carried out by a non-ordained religious, then the guidance outlined in Guidance 1.1C must be followed.

### Visiting Clerics celebrating or concelebrating Mass at Shrines outside Ireland

- If the Shrine is outside of Ireland all child safeguarding requirements of the organisation within which the ministry takes place must be followed, in accordance with Guidance 2.1J.
- The main celebrant must allocate responsibility for each cleric wishing to concelebrate to have their celebret cards checked to ensure they are in good standing.
- A cleric who is out of ministry due to child safeguarding concerns must not attempt to celebrate any sacrament in public while abroad.

### CELEBRETS/LETTERS OF GOOD STANDING

All steps must be taken to ensure a safe and nurturing environment within the Church for children. For that reason, it is important that all those who engage in public ministry require confirmation that they are fit for that sacred task. The safeguarding of children within the Irish Catholic Church is of critical importance. All clerics who wish to minister in a Church which is not their own Church must show their celebret or letter of good standing; if this is not available, the cleric cannot be allowed to minister in public.

### Reporting child protection suspicions, concerns, knowledge or allegations to An Garda Síochána

An Garda Síochána have clarified with the NBSCCCI that the telephone number of the Gardai National Protective Services Bureau (01 6663430 or 01 6663435) *should only be used when referring allegations against clerics or religious*. This number is on all new Policy Posters. If the allegation is related to a lay member of Church personnel or the allegation is about someone who is not a member of Church personnel, then the local Garda station number should be used.



## Frequently Asked Questions in 2017 & 2018?

### **If a parent or guardian refuses to sign a media permission form, what is the position of a class photograph on days such as Holy Communion or Confirmation?**

The Church body is only responsible for photographs taken for church purposes. If it is the Church body organising the photograph and using it, then this situation is best dealt with by the member of Church personnel responsible of the children; ultimately the photograph cannot be taken without parental permission. In practice, what often happens is that the member of Church personnel speaks to the parent/guardian of the children concerned and explains to them that the child will not be able to be in the photograph, and then the parent/guardian will be responsible for removing the child and ensuring that they are not disappointed because of not being in the photograph.

If the school or another group are organising the photograph or other parents, it is their responsibility to ensure that media consent is in place.

### **Although all Leaders in a Sunday School are vetted some parents have requested to come to look after their child, do they need vetted?**

If a parent is coming just to look after solely their own child and no others then they do not require vetting. However, if they are looking after other children and they fulfil the requirements for vetting under the legislation then they must be vetted.

### **Are there consequences for reporting concerns that turn out to be false?**

The Protection for Persons Reporting Child Abuse Act (1998) specifically states that if you have reported a concern 'reasonably and good faith' you will not be liable for civil damages.

### **Whose responsibility is it to tell parents when a child has disclosed?**

Always seek advice from the DLP and/or social services about this.

### **What if I am unsure if there are indicators of abuse, can I seek advice from somebody?**

If you are unsure always seek advice from an appropriate person, such as the DLP or the statutory authorities. They will help advise you what to do next.

## Children First Guidance and Supporting Documents 2017

Katherine Zappone, Minister for Children and Youth Affairs announced that the remaining sections of the Children First Act 2015 would commence on 11th December 2017. In addition, she launched the revised Children First: National Guidance for the Protection and Welfare of Children 2017. Tusla has also launched a complementary suite of supporting documents and will add to these after December 11th.

Two very important sections of the 2015 Act will, when commenced, have important implications for child safeguarding work in the Church. From 11th December 2017 the provision relating to Mandatory Reporting will become law in the Republic of Ireland; as will the requirement for organisations that have ministry with children to prepare their Child Safeguarding Statements. The National Board is reviewing its own Guidance to ensure complete clarity around these two requirements, and we will issue amended guidance in the near future.

Mandated persons are people who have contact with children and/or families and who, because of their qualifications, training and/or employment role, are in a key position to help protect children from harm. ***Within a Church context a mandated person is a member of clergy and a pastoral care worker, or someone involved in child safeguarding i.e. Designated Liaison Person.***

Mandated persons have two main legal obligations under the Children First Act 2015. These are:

1. To report to Tusla harm to children that is above a defined threshold; and
2. If requested, to assist Tusla in assessing a concern which has been the subject of a mandated report.

A Child Safeguarding Statement includes an assessment of risk of 'harm' to a child who is availing of your service, and the statement specifies the procedures in place to manage any risks so identified. ***It must be understood that the Child Safeguarding Statement does not replace the Child Safeguarding Policy, but it sits alongside it and should reference the relevant sections of the policy.*** Copies of the Children First Safeguarding Statement along with the relevant reporting forms have been sent to every parish in the diocese and are available on the diocesan website. Please contact the Safeguarding Office if you wish to receive a copy.

## GDPR and Data Protection

The General Data Protection Regulation (GDPR) is a European Union legal instrument ensuring the protection of individuals regarding the processing of personal data and on the free movement of such data. It is designed to give citizens more control over their data by bringing laws and obligations across Europe up-to-speed for the internet-connected age. It legalises the fundamental right of every living person to control their personal information, and have it adequately protected by anyone processing and holding it.

The GDPR came into effect from 25 May 2018.

### Six General Data Protection Principles

- Fairness
- Purpose limitation
- Data minimisation
- Accuracy
- Storage limitation
- Security

### Personal Data

Data protection is how the privacy rights of individuals are safeguarded in relation to the processing of their personal data. Personal data is data relating to a living person who is, or can be, identified from the data, or from the data in conjunction with other information that is in, or likely to come into, the possession of the data controller (the person who controls the contents and use of the data).

The individual (data subject) has rights, including:

- To be informed about personal data held
- To access to personal data
- To rectification (of inaccurate data)
- To be forgotten (erasure)
- To restrict processing
- To data portability

The Diocese of Raphoe is currently consulting with Sytorus Data Protection Specialists to put in place a Policy on Data Protection which will be designed for parishes, the parish being the “data controller” with primary responsibility for, and a duty of care towards the personal data within its control.

## World Meeting of Families, Pope Francis and Child Safeguarding

There was considerable media interest in the WMOF, and the Papal visit and it would appear their particular interest was highlighting the deficits in managing allegations that are so much part of the narrative of child safeguarding in the Catholic Church. It is easy to become disillusioned and to think that the failures in terms of inadequate responses to allegations are the full story of child safeguarding. No one was terribly interested in what has been effective in turning the tragic reality of previous management of allegations into a better reality today. Pope Francis himself commended the Irish Church for its robust norms, in his final address to the Irish Bishops. “A recurrent theme of my visit, of course, has been the Church’s need to acknowledge and remedy, with evangelical honesty and courage, past failures – grave sins – with regard to the protection of children and vulnerable adults. Among these, women who were mistreated.

In recent years, you as a body have resolutely moved forward, not only by undertaking paths of purification and reconciliation with victims and survivors of abuse, but also, with the help of the National Board for Safeguarding Children in the Church in Ireland, you have set in place a stringent set of norms aimed at ensuring the safety of young persons.

In these years, all of us have had our eyes opened – painfully – to the gravity and extent of sexual abuse and the abuse of power and conscience in various social settings. In Ireland, as elsewhere, the honesty and integrity with which the Church chooses to confront this painful chapter of her history can offer an example and a warning to society as a whole. Continue on this path. Humiliation is painful, but we have been saved by the humiliation of the Son of God and this gives us courage. The wounds of Christ give us courage. I ask you, please, to be close – this is the word, “closeness” – to the Lord and to God’s people. Closeness. Do not repeat the attitudes of aloofness and clericalism that at times in your history have given the real image of an authoritarian, harsh and autocratic Church.

The message that the National Board takes from the anger and concern expressed by survivors and others during the WMOF is that we need to have a renewed vigor when responding to those who come forward with allegations.

## STANDARD 7– Implementing and Monitoring

### Parish Self Audits 2016 & 2017

Parish Self Audits are carried out on an annual basis. The format of the Audit form is based on the Seven Standards and Guidance Document for the Catholic Church in Ireland together with National Guidelines. The completion of the Audit is a requirement of the National Board for all parishes throughout Ireland, North and South. The self-audit tool is a way of measuring how close your parish is to meeting the Seven Standards for keeping children safe.

The 2016 Parish Audits form part of the 2017 - 2018 Annual Report as the cut off point for returns is generally April of the following year i.e. April 2017. This gives a more accurate reflection with an average 95% compliance.

In 2017, 38 Parish Audits were returned to the Safeguarding Office. All returned audits reported good compliance with all Seven Standards and no concerns had been reported.

Having examined all 41 audits, good compliance was noted throughout the Diocese. Only 2 audits remain outstanding, Kincasslagh and Glenswilly.

No concerns were reported in the returned Audits of 2016.
