#### **REVIEW OF SAFEGUARDING PRACTICE**



In December 2022, Bishop Alan invited the National Board for Safeguarding Children to conduct a review of safeguarding practice within the Diocese. Two independent Reviewers were appointed. They spent 3 days (5<sup>th</sup> to 7<sup>th</sup> December) examining case files from the date of the last review in August 2010 to current date. They visited two parishes and spoke with clergy, sacristans and parish reps. They also met with staff working in youth ministry (NET Ministries), Lourdes Pilgrimage Office staff, Rainbows Coordinator, Children of the Eucharist Leaders and the Counselling Co-ordinator at the Pastoral Centre. They spoke with representatives from an Garda Síochána and Tüsla, along with our Safeguarding Committee and Trainers. The Reviewers were satisfied that the Diocese meets with all Seven Standards of Safeguarding. Our sincere thanks to all those who participated in the Review and to all who ensure best practice continues to be paramount when working with children/young people and vulnerable adults in our diocese.

### HOW TO REPORT A CONCERN



If you have a suspicion or concern that a child is at risk of abuse, you must act on it immediately by reporting the matter to the Designated Liaison Person. The DLP is the person appointed by the bishop to receive child safeguarding concerns and to pass this information on to the Gardaí and Tüsla.

The presence of the Sacristy Register and the time taken to fill it in is also a reminder to those present of the priority given to Safeguarding in the Parishes of the Raphoe Diocese.
