NEWS & UPDATES

A Safe and Welcoming Church – Safeguarding Children Policy and Standards for the Catholic Church in Ireland, 2024.



The National Board has a responsibility to advise the Catholic Church in Ireland on Child Safeguarding Policy and Practice. Since its foundation, the National Board has developed three iterations of a child safeguarding policy, the most recent in 2024. Since the publication of the previous document in 2016, there have been significant changes in canon law, some changes in civil law, and much increased awareness about effective practice in the area of child safeguarding, particularly within a faith-based setting.

In January 2022 an extensive process begun involving listening meetings and consultation across all Dioceses and Religious Orders. The revised policy was launched in June 2024 is entitled: 'A Safe and Welcoming Church - Child Safeguarding Policy and Standards for the catholic Church in Ireland 2024' and can be accessed on the Diocesan website - www.raphoediocese/safeguarding.ie

There are three core standards to the Church's Safeguarding Children Policy (the three standards are linked, and no standard is more important than another):

- 1. Leadership, Governance and Accountability
- 2. Nurturing a Culture of Safeguarding
- 3. Responding Pastorally and Reporting according to Civil and Canon Law.

"The participation of children and young people in the life of the Church is essential to our mission. This policy, designed by the National Board for Safeguarding Children in the Catholic Church in Ireland (the National Board) and informed by and embedded in Gospel values and in the rights of children, presents the most up-to-date, best-practice opportunity for all members of the Catholic Church in Ireland to ensure that all ministry with children is safe, and that children can remain central to the mission of living the Gospel here in Ireland."



Teresa has been appointed by Pope Francis to the Catholic Church's Commission for the Protection of Children, we wish her well on this new appointment and have no doubt that she will continue to enrich the Church with her care and compassion for this work.

Aidan Gordon, the former Director of Safeguarding for the Archdiocese of Armagh, has been appointed as the new Chief Executive of the National Board for Safeguarding Children in the Catholic Church. **Dr. Niall Moore** has taken up a new position with the Church of Ireland and has been succeeded as Director of Training and Support by **Ms. Lyn McDermott**. We wish them both well in their new roles and look forward to working with them both in the future.

Changes to our Safeguarding Committee

Barry Ramsay, former Principal Social Worker has been a Safeguarding Trainer & Committee Member since 2013 and has probably visited every Parish in the Diocese, more than once! Barry has now chosen to retire, and we send with him our sincere thanks for the dedicated service he offered and every good wish for his future exploits.

Earlier this year, we also said farewell to **Fr. Gerard Cunningham**, PP, Glenties who served on our Committee since 2012 and stepped down due to parish commitments. Fr. Gerard's insights at parish level made a valuable contribution to Safeguarding. The Committee have recently welcomed **Fr. Ciaran Harkin**, **PP**, Irish Martyrs on board and look forward to working with him in the future.

Sadly, former Trainer & Committee Member, **John Kennedy**, Coolcholly, Ballyshannon passed away last September. John along with Sr. Mary O'Donovan were pioneers of Safeguarding Children in the Diocese of Raphoe. John's many years as a member of an Garda Síochána enriched his role as a Safeguarding Trainer along with his sense of humour. We are indebted to John for his outstanding service and contribution to safeguarding.

IMPORTANT CHANGES TO THE NVB1 – VETTING INVITATION FORM

The National Vetting Bureau has established a Compliance Unit who regularly conducts audits of garda vetting applications. A requirement of the Vetting Bureau is that applicants applying for garda vetting must have their identification items validated by their Parish Priest/Curate/Parish Secretary. Identification must include photographic ID and Proof of current address dated within the last 6 months. Please refer to *Section 3* of the NVB1 Form.

On average, 1 in 5 applications is incomplete, please make sure you read the instructions provided carefully to avoid delays in processing applications.



- 6. Responding to a Concern, Complaint or Suspicion of Abuse
- 7. How to deal with Allegations Made Against Volunteer or Staff
- 8. Record Keeping & Confidentiality
- 9. Data Protection
- 10. Useful Contact Details.

In line with Children First 2015 legislation, the Child Safeguarding Statement was also updated. Risk Assessments were carried out for both Young Persons and Assisted Pilgrims. The Director of Safeguarding and the Lourdes Leadership Team worked together on establishing a comprehensive Risk Assessment. Our thanks to Ger Growley, Director of Safeguarding Limerick who generously shared their Risk Assessment Template.



PARISH SELF-AUDITS

Parish Self Audits are carried out on an annual basis. The format of the Audit form is based on the Seven Standards and Guidance Document for the Catholic Church in Ireland together with National Guidelines. The completion of the Audit is a requirement of the National Board for all parishes throughout Ireland, North and South. The self-audit tool is a way of measuring how close your parish is to meeting the Seven Standards for keeping children safe.
